Frequently Asked Questions

- *How does The Longleaf Alliance's Planting Fund work?*

This is a reimbursement/rebate program. **The landowner is responsible for all the work and will be reimbursed after the project is completed.**

- *Is there a minimum number of trees or acreage requirement to apply?*

Requests must include a minimum of 5,000 trees. There is not a minimum acreage.

- *Who is eligible to submit a request? Are the planting funds only for nonindustrial private forests?*

Let us know your category of landownership; these programs continue to grow, and **we are accepting requests for public and private lands.**

- *Are there maximum income restrictions?*

The request form does not include this information, so don't let that be a limitation.

- *What practices are covered?*

We are gathering information here about planting plans and seedling needs. **Most funds are available to assist with the cost of trees only.**

Information for all project expenses can be included with your request as there is the possibility of covering other expenses, but these funds are limited. Contact us directly to connect to other incentives available for longleaf.

- *Can I submit a request if I have applied for another financial incentive opportunity?*

Planting funds may be used in combination with other funding, but the same practice on the same tract cannot be covered twice.

- *What is the deadline to submit the request?*

Requests must be received by June 1.

- *Can I save my request and finish it later?*

Each request generates a unique URL. To come back later, bookmark the URL in your web browser or copy/save it to access it later. If you need assistance retrieving your submission for updates, please contact Sarah Crate at sarah@longleafalliance.org.

- *I submitted my request but need to make a change. How can I update it?*

Once your request is received, you will receive a confirmation email from sarah@longleafalliance.org. The email contains your unique URL that can be used to review or edit the information until the application deadline of June 1st.

- *When will I be notified?*

Applications will be reviewed over the summer, and **notifications are anticipated in late fall.** Notification timing is dependent on finalization of partner collaborations and grant funding. We intend to help as many landowners as we can with the available funds.

Submission does NOT guarantee acceptance into the program. You will receive additional correspondence with instructions on submitting your reimbursement. It is important that you reply to all correspondence.

How to Get Started

Thank you for your interest in longleaf pine funding assistance. Your request helps us determine the planting needs, but does not guarantee that funding will be available.

Please review our [FAQs](#) before submitting your application.

This funding request is open until June 1st, but applicants are encourage to apply early as funding opportunities may arise before the deadline. Applications will be reviewed and notifications anticipated in late fall (starting in November).

To complete your longleaf planting fund request, you will need the following information:

- **Landowner/project contact information**
- **Map of planting area**
- **Project site photo (optional)**
- **GPS coordinates of planting site**
- **Acres to be planted**
- **Number of trees to be planted (*minimum of 5,000 trees required to apply*)**
- **Estimated cost**
- **Additional project information including project goals**

As always, we encourage folks to order longleaf seedlings early! Waiting until you hear back about a cost-share application may be too late to guarantee seedlings.
